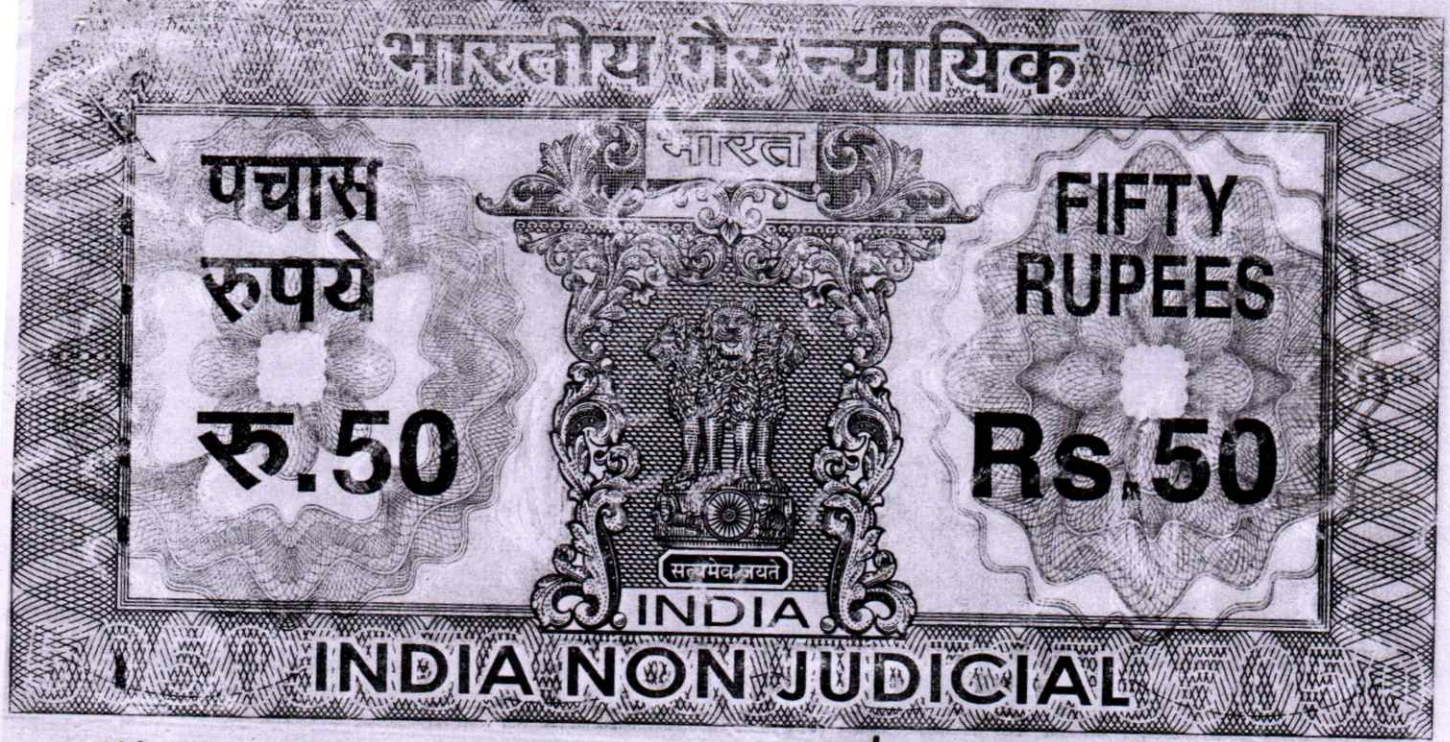

THIS DEED OF TRUST made at WALAJAPET on the 23rd June 2016 by P. KARTHIK KRISHNAN Son of T.G. Pandurangan Hindu, Aged 34 years residing at Old No.27, Chetty Street, New No.53, Kamaraj Street, Walajapet of Walajapet Taluk, Vellore District of Tamilnadu, SANTHIYA. K wife of P. Karthik Krishnan Hindu, aged 29 years residing at Old No.27, Chetty Street, New No.53, Kamaraj Street, Walajapet of Walajapet Taluk, Vellore District of Tamilnadu are hereafter called as "FOUNDERS OF TRUST".

1. WHEREAS the Founders are desire of instituting a Public Charitable Trust.

2. WHEREAS the Founders with a view to give effect to the said desire, constituted a Trust in the name and style of SANTHYA KARTHIK KRISHNAN EDUCATIONAL TRUST.

3. WHEREAS prior to the execution of these presents, the founders transferred and delivered to the Board of Trustees a sum of Rs.1,008/- (Rupees One Thousand and Eight Only) by cash with a view to rest with the Board of Trustees some nucleus of property to start.

5. WHEREAS the Trustees hereto have agreed to join and manage and administer the same collectively as a committee on the regulations hereinafter appearing.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

NAME OF THE TRUST

The Trust hereby declared and constituted as a Public Charitable Trust and shall be designated as "SANTHIYA KARTHIK KRISHNAN EDUCATIONAL TRUST" hereinafter called as the Trust.

REGISTERED OFFICE

The Registered Office of the Trust shall be at Old No.27, Chetty Street, New No.53, Kamaraj Street, Walajapet of Walajapet Taluk, Vellore District, Tamilnadu and or as such other place as the Trustees may decide from time to time.

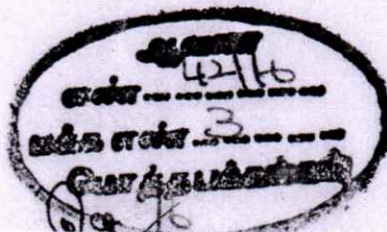

3. OBJECTS OF THE TRUST

- A) To establish, to take over or acquire and maintain and manage schools, colleges and other educational institutions, hostels, orphanage, charitable organizations.
- B) To award scholarships, stipends to students in India and to enable their studies in India or in foreign countries and for purchasing books, to award prizes to students for proficiency in any subjects or languages and to promote or encourage spirit of sports among student community.
- C) To promote study and research in any subject and afford facilities to those who conduct such study and research on any subject or field of science or Engineering or Technologies etc.
- D) To give financial or corporal aid, assistance or other helps to deserving persons individual or community or society.
- E) To impart training for advancement of knowledge in any subject or languages or discipline.
- F) To establish, maintain conduct and manage hospitals, clinic or camps, laboratories and Medical Colleges and Medical Research Centers and to provide the poor with medical aid.

- G) To give subscriptions or donations to any charitable institutions or body with proper recognition.
- H) To accept, upon such terms as they shall think fit, any donations, grants, subscription, aid and contributions from any Government, local authority, corporation, firm, company syndicate, association, or other person or form any charitable or other institution whether they be in cash or in other movable or immovable property for the purposes of the trust PROVIDED ALWAYS that the terms upon which they shall be accepted shall not in any way be inconsistent with repugnant to the provisions contained shall be applied for all or any of the objects of the Trust.
- I) To acquire by purchase, lease or otherwise any property whether movable or immovable or any rights for the purpose of the trust and to sell, give on lease mortgage or otherwise transfer any such property or rights.
- J) To construct, maintain or alter any building or works necessary for the purpose of the trust.
- K) To borrow money for the purposes of the Trust upon any terms and conditions either with or without interest.
- L) To receive grants from any agencies including Central Board for the workers Education and to conduct programme for them.

- M) To do such activity / activities for furtherance of Art, Literature, Music etc.,
- N) To spread knowledge and education by publication of books, periodicals, journals, literature etc.,
- O) To give monetary aid or other help for relief from natural calamities like floods, cyclone, tempest or otherwise, to give monetary aid or other help for the disposal of dead persons or cremation or performance of obsequies.
- P) To give aid for the promotion of agriculture horticulture and the like and for research in the same subjects.
- Q) To assist renovation of places of historic, archaeological or artistic importance.
- R) To do all such other lawful things as may be considered incidental or conducive to the attainment of the objects mentioned above.

4. INVESTMENTS

All monies which shall not immediately be required for current expenses shall be invested by the Trustees in investments and securities authorized by law according to the provisions of section 13(1) (d) read with section 11 (5) of the Income Tax Act 1961 or other relevant provisions of law for the time being in force and shall be in the name of Trust only. The Trust has to apply to the income Tax departments for Registering the Trust Under 12AA and 80G of the Income Tax Act 1961.

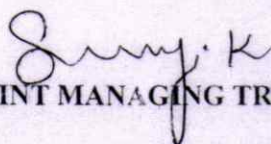
Not more than 5% of the income of the Trust / Institution would be applied to any religious purpose or given to religious Institutions (any violation found lead to denial of Exemption under section 80G considering the Trust as Public Religious in nature)

5. TRUST FUND

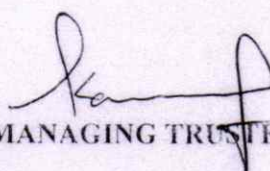
The authors of the Trust declare that the sum Rs.1,008/- (Rupees One Thousand and Eight Only) that has been dedicated by them for public charitable purpose and objects of general public utility described above, the receipt of which the TRUSTEES have acknowledged and that the TRUSTEES shall and will stand possessed of the said sum of Rs.1,008/- (Rupees One Thousand and Eight Only) upon Trust and also any other properties, movable or immovable, which the Trustees may from time to time receive for augmenting the Trust Fund or for specified purposes connected with the objects of the trust not calculated to impede the due working of the trust arising from donations bequests, gifts, legacies or grants in such or kind or from any other source whatsoever and also of any investments for the time being representing the same (hereinafter called the Trust Fund) and also of the net income from the Trust Fund into Trust, and to apply both the income and the capital of the Trust Fund for the purposes of the Trust.

The Trust Fund shall be held in the name of the Trust and not in the name or names of the TRUSTEES.

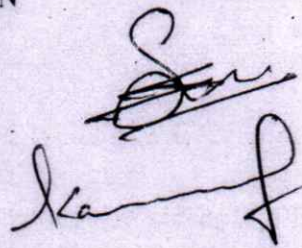
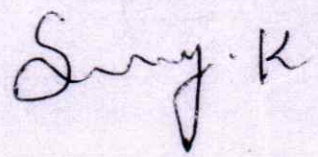
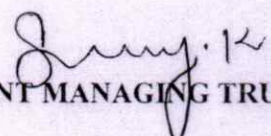
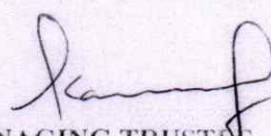

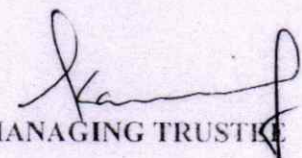


- (b) The Board of Trustees shall consist of not less than 2 and not more than 15.
- (c) The Trustees shall be trustees for their life time or till their seat comes vacant or is vacated by due process.
- (d) The number of Trustees may be altered according to the decision of the Board Trustees subject to (b) supra.
- (e) The Trustees shall hold such office as Trustee during their life time unless they should vacate the office earlier for any reason whatsoever. In the event of there being a vacancy in the office of such trustee, it shall be filled up by co-option by remaining trustees. In the event of a Trustee retiring on his/her own, the person nominated by him/her, on behalf shall take the place of such retiring, if the remaining Trustees co-opt for the same.

7. POWER OF THE BOARD :

- A) The Board of Trustees shall have all powers necessary or incidental for effectually carrying out the objects of the trust.
- B) Subject to the general provisions of the Trust and without prejudice to the general and specified powers conferred by the other provisions contained in THESE PRESENTS, the Board of Trustees shall have the following powers also.
 - a) To apply the Trust monies to effectuate one subject or some of the objects of the trust in preference of the other objects.
 - b) To discontinue the application of the Trust funds to one object and diver the funds to another object.
 - c) To determine the terms and conditions on which any donations, subscriptions, scholarships or prizes are to be given by Trust.
 - d) To extend the funds of the Trust in such manner as they shall consider most beneficial for the purposes of the Trust.
 - e) To acquire, build upon pull down, re-build, and to alter, repair, improve, sell or dispose off or otherwise deal with any land, building or premises or property of the use of the Trust.
 - f) To take any property on lease or hire.
 - g) To acquire any property.
 - h) To enter into any contracts on behalf of the Trust.

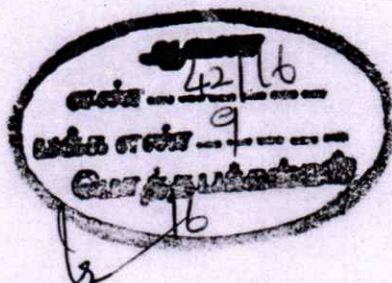

- s) To make and from time repeal or alter the regulations.
- i) As to the details of management of the trust and the affairs thereof.
 - ii) As to the duties of any officers or servants of the trust.
 - iii) As to the conduct or any of the matters or things within the powers or under the control of the board provided that the same shall not be inconsistent with the provisions contained in these presents.
- t) To settle out of the court, compromise or compound all suits, actions and other proceedings and all differences or demands and to refer all or any of such differences or and approve all accounts without being answerable for any loss occasioned thereby.
- u) To appoint and dismiss manager, secretaries, clerks and other staff and at their discretion remove, dismiss or temporary or special service in connection with the work of the Trust, Trust estate, Trust properties as they may from time to time think fit and determine their powers and duties and fix their Emoluments and to require security in such instance and such amounts as the Trustees may think fit. The Trustees shall also have power to found and maintain provident funds, gratuity funds, personals and other funds for any employees and make rules and regulations regarding the same.
- v) To do or consider and implement other incidental affairs or activities, as deem fit related – these aims and agreeable to law.

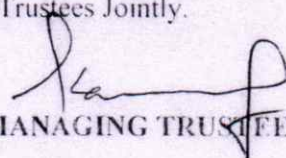
8. CUSTODY OF DOCUMENT

The Managing Trustee and the Joint Managing Trustee shall have custody of all deeds and documents of title relating of Trust Properties and investments and the books of account and other records relating to the trust and shall be responsible for the same and their safe custody.

9. BANK ACCOUNT

All income, subscriptions and pecuniary donations for the general purpose of the trust and the income of investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being receipted to be paid into to bank account for accounts with any scheduled bank or banks which the board may determine. Such bank accounts may be operated either by Managing Trustee and the Joint Managing Trustee Jointly or any two of the Board of Trustees Jointly.

10. ACCOUNTS AND AUDIT

- a) The Managing Trustee and the Joint managing Trustee shall keep proper accounts of the income and expenditure of the Trust, shall prepare a financial statement of the income and expenditure of the Trust, shall prepare a financial statement and Balance Sheet for every year as on the last date of 31st March and signed by the Managing Trustee and the Joint Managing Trustee.
- b) The accounts shall be got audited by a Chartered Accountant appointed by the Trust for this purpose and who shall not be a member in board;

11. TERMS OF OFFICE OF THE TRUSTEES

ALL TRUSTEES of the Trust shall hold office for life or until they resign.

12. POWERS TO CO-OPT

The Trustees shall have the power to co-opt additional Trustees or to fill up any existing vacancy in the Board of Trustees. However, that the total number of Trustees shall not be in low or exceed the number fixed in 6(b) supra.

13. VACANCIES OCCURRING IN THE OFFICE OF THE TRUSTEES :

The vacancies occurring in the office of the Trustees shall be filled by the remaining Trustees within 3 months of the arising of such vacancies. If there are no Trustees, functioning of at any point of time, the TRUSTEES shall be appointed in accordance with law by a Court of competent jurisdiction. Where at any time the number of TRUSTEES falls below the minimum prescribed in clause 6(b) supra, the continuing TRUSTEES shall the power to co-opt any person or persons to fill up such vacancy.

14. VACANCY NOT TO INVALIDATE THE PROCEEDING :

Any Vacancy in the Board of Trustees and / or any illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board of Trustees.

15. ADMINISTRATION

The Board of Trustees shall have full power and authority to administer the Trust its properties and affairs and to do all acts, deeds and things which are calculated to fulfill the performance for which the TRUST is established. The Board of Trustees shall act through the managing Trustee.

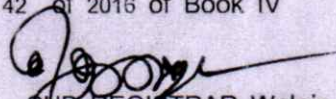

23. TRUSTEES AND RELATIVES NOT TO BENEFIT :

Notwithstanding the power vested with the Trustees under the proceeding clauses, no part of the income of the Trust shall ensure directly or indirectly and no part of the income or property of the Trust shall be used or applied directly or indirectly, for the benefit of the Trustees or any person who makes a substantial contribution.

24. LIABILITY OF TRUSTEE OR TRUSTEES :

In the professed execution of the Trust and power conferred, no Trustee shall be liable for any loss to the Trust properties arising by reason of improper investment made in good faith or for the negligence or fraud of any agent or employee employed by him or by any other Trustee hereof although the employment of such agent shall not strictly be necessary or expedient or by reason of any mistake or omission made in good faith by the Trustees or by reason of any other matter or thing except willful or deliberates fraud on the part of the Trustees, who alone may be subject to be made so liable.

GENERAL :

25. The Trust is irrevocable.
26. The Trust hereby constituted fails for any reasons: the net assets of the Trust shall be made over to any public Charitable Trust having objects similar to this Trust.
27. The income and fund of the trust will be solely towards the objects and no portion of it will be used for payments to the Trustees where it contradicts to section 13(1) (c) of Act 1961.
28. The benefits of the Trust are open to all irrespective of caste, religion, sex etc.
29. Any amendment to the Trust Deed will be carried out only with the approval of the Director of Income Tax (Exemptions), Chennai - 34.
30. No. activities of the Trust will be carried out anywhere outside India.
31. The Trust will not carry on any activity with the object of earning a profit.
32. The seal of trust shall bear the inscription "SANTHIYA KARTHIK KRISHNAN EDUCATIONAL TRUST" and shall remain in the custody of control of the Managing Trustee.
33. The Trustees shall be entitled to be indemnified by the Trust Properties against the consequences of all lawful acts done by the Trustees in the course of and discharge of their duties as Trustees of the Trust and all costs, charges and expenses thereof.

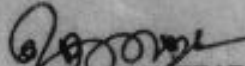

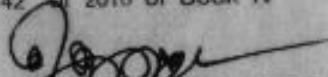
